#### DISCLAIMER



**Respondents:** This count includes sheltered and unsheltered individuals and is based on the number of individuals surveyed who indicated they lacked permanent, stable housing. Our count includes doubled-up individuals (staying with a friend or family member) and individuals who were sleeping in a hotel/motel they paid for. These individuals are not considered "literally homeless" by the Department of Housing and Urban Development (HUD) and won't be included in the data compiled by our Continuum of Care (MACH).

**Accuracy:** The data presented in this report is based on the individuals our staff, volunteers, or fellow service providers were able to make contact with over the span of a few days. Historically, the PIT Count under-represents the number of individuals experiencing homelessness within a community.

**Clarification:** The data points presented reflect the number of individuals who responded to the question, not the total number of people included in the count/survey.

#### ACKNOWLEDGMENT



Each number and statistic detailed in this report signifies a human life. These individuals are integral members of our community, facing threats and hardships due to inadequate access to affordable housing. For every person counted, there are likely numerous others enduring the challenges of homelessness and housing instability within our community.





### **78.8%** of individuals are of employment age




According to a HUD 2023 report completed by the Joint Center for Housing Studies of Harvard University, "the 65 and older age group is the fastest growing among those experiencing homelessness." The article confirms that "Age-related challenges to housing security include the struggle to afford rent increases on a fixed income, the need for accessible housing and additional services, and increasing vulnerabilities and risk factors, such as physical and cognitive disabilities."



#### Data

47.4% of individuals reported that their race/ethnicity was Black, African American, or African.48.7% of individuals reported that their race/ethnicity was White.


#### <u>Context</u>

<u>The U.S. Census Bureau's</u> Population estimates indicate that over 74% of the overall population in Lancaster County is White, while less than 21% is Black.

#### Why it Matters

The data collected during the PIT Count supports national data that Black, Indigenous, and Multi-Racial people are more likely to experience homelessness than White individuals due to "<u>historical and structural racism</u>."



\*Unsheltered locations include abandoned buildings, airports, bus or train stations, parks, street or sidewalks, encampments, vehicles, or other areas not meant for human habitation.




#### SHELTERED SLEEP LOCATION

#### UNSHELTERED SLEEP LOCATION






#### LANCASTER COUNTY PIT COUNT DATA



#### 27% of individuals were identified as Kershaw residents



MYTH: Our Homeless are not from Lancaster or South Carolina. 88% of individuals identified Lancaster as their last permanent address
92% of individuals identified South Carolina as their last permanent address

\*Only six individuals identified an area outside of SC as their last permanent address, three of those individuals were from North Carolina\*




#### NUMBER OF EXPERIENCES

\*ALICE, a United Way acronym which stands for Asset Limited, Income Constrained, Employed, represents the increasing number of individuals and families who work, but are unable to meet their basic needs, including food, child care, housing, health care and transportation.\*
